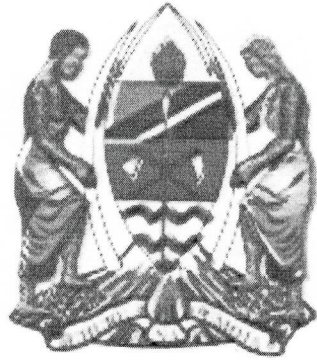

1. The Maweni Regional Referral Hospital, Kigoma is expecting to spend some of its fund to implement various development activities for improving health facilities as the government policy for the citizens. The Maweni Regional Referral Hospital under the financial year 2021/2022 planned to prepare the General Site Layout Plan to cater for future effective and efficient hospital development.
2. The overall objective of this assignment is to lay foundation for effective hospital development that aim at guiding and managing its growth. An overall objective of stimulating as well as enhancing good arrangement and connectivity between the buildings and Hospital services. This site layout plan will combat rapid growth due to intra building improvement.
3. The Maweni Regional Referral Hospital, Kigoma now invites eligible firms (consultants) to indicate their interest in providing their services. Interested consultant should provide information demonstrating that they have the required qualification, relevance experience and ability to perform the service. The short-listing criteria are (including the evidence of experience):
  - i. Experience in development/preparation of general Site Layout Plan
  - ii. Experience in design of various buildings
  - iii. Experience in design of various systems
  - iv. Experience in conducting Geotechnical survey
  - v. Qualified firm staff in relevant field.
4. Firm may associate with other firm in the form of joint venture or a sub consultancy to enhance their qualifications.
5. The consultant will have to submit the proposal that will comply with TOR that will be provided at Maweni Regional Referral Hospital through Procurement office. The applicant will have to pay **Tsh 200,000/=** in order to take TOR that will be used for preparation of proposal. The consultants who will be interested will take control number at accountant office at Maweni regional Referral Hospital. During submission of TOR tender document the original receipt of payment should be attached. The attention of interested firms/consultant (s) is drawn in the public Procurement Act2011.
6. Interested consultants may obtain further information at Maweni Regional Referral Hospital, Kigoma in Procurement Office during office hours from 8:30am to 3:30pm local time from Monday to Friday excluding public holidays.
7. The deadline for submission of proposal will be on Tuesday, March 29<sup>th</sup>, 2022 at 11:00am local time, to be addressed to the Secretary, Council Tender Board, Maweni Regional Referral Hospital, Kigoma, Lumumba Road, P.O Box 16 Kigoma, Tanzania. Opening will be promptly thereafter in public and in the

presence of firm's representatives who wish to attend in the opening at Eye Block in Maweni regional Referral Hospital. Proposals should be submitted in writing and have to be enclosed in plane sealed envelope.

8. All documents that will be sent electronically or after deadline will not be accepted.
